Some boxes do not have file numbers. This is either because the box contains a bundle of papers or a set of volumes. When there is no file number readers should quote the box number and be as precise as possible in giving a description for the item they want eg. 'Reference Number': Boxes 2-5/ Matriculation & School Examinations Council: minutes, 1945.

Some items are closed due to the Data Protection Act (DPA). This is made clear in the 'Access Restrictions' column. If this is empty then the item is open to researchers.
