### Pakistan Election 2002 - Commonwealth Observer notes (ICS162)

This comprises briefing and administrative notes, press cuttings, manifestos, and reports relating to the Commonwealth Observer group for the 2002 Pakistan general election. These have been donated by Richard Bourne, who was observing the election in the tehsil of Faisalabad.
