Jack Halpern was born in 1927 in Berlin. Because of the Nazi persecution of the Jews, his parents brought him to Johannesburg, where he was educated. His interest in the problems of developing countries was stimulated by two and a half years subsequently spent in Israel, where he was a member of a Kibbutz and later joined the technical staff of the national company bringing water to the Negev desert. Returning to South Africa, he took up journalism and married. After editing technical and industrial journals, he became Editor and Publications Officer of the South African Institute of Race Relations. In 1960 Mr. Halpern was invited to edit The Central African Examiner in Salisbury, Southern Rhodesia, and became the Central African Correspondent of the Observer, the New Statesman, Dagens Nyheter and Politiken. In September 1963, with the Rhodesia Front in power, he and his wife were arbitrarily expelled from the disintegrating federation of Rhodesia and Nyasaland by Sir Roy Welensky. Since coming to Britain, Mr. Halpern served as Secretary-General of Amnesty International and writing under his nom-de-plume of James Fairbairn, as Africa Correspondent of the New Statesman. He contributed widely on race relations and the problems of Southern and Central Africa to journals in these areas, in Britain and in the United States. He died on 11 May 1973.

Jack Halpern's papers, deposited by his widow, comprise press cuttings, press releases, official and non-official publications, correspondence and transcripts of radio and television programmes relating to South Africa from c.1958 to his expulsion in 1963. There are also copies of newspaper articles written by him as James Fairbairn as well as under his own name. This material has been divided by area and then by type of material, so that there are files covering South Africa; High Commission Territories; Swaziland; Lesotho; Botswana; Central African Federation; Malawi and Zambia; and Rhodesia.

There is a large amount of material relating to his authorship of *South Africa's Hostages*, including draft chapters and notes, and from his period with Amnesty International there are 6 files of documents, press cuttings and correspondence.

There are 6 files of general and family correspondence and 7 files of miscellaneous unpublished and printed material. This includes J.H.'s notebooks and appointment diaries. There is also a file of Sophie H.'s correspondence. Finally there are 62 envelopes of press cuttings arranged by subject.
