

## **ICS 36 International Transport Workers Federation: Reports on Africa**

The International Transport Workers' Federation was founded in London in 1886 by European seafarers and dockers' union leaders who realised the need to organize internationally against strike breakers. This collection contains: Reports on Africa, 1952-1975 comprising reports on conditions for port, shipping, bus, railway and airline workers in Rhodesia, Nigeria, Tanganyika, Uganda, Kenya, South Africa, and Ghana. Includes articles by O Becu on apartheid and the international trade union movement, 1957; reports on the employment of non-white bus crews in South Africa; and general reports on ITF activities in Africa.
