ICS 50 Anthony McAdam Papers

Anthony McAdam was a Lecturer in the Department of Political Sciences, University College, Rhodesia in the 1960s and early 1970s. He later taught at Stirling University.

This collection comprises of papers relating to Rhodesian politics collected by McAdam between 1964 and 1972, including correspondence and papers relating to the multiracial University College Rhodesia, 1964-1971; correspondence and papers relating to African National Congress (ANC) meetings, particularly relating to the ANC Committee in London, 1971-1972; miscellaneous material on Rhodesia, 1970-1972, including correspondence on the right of entry to the United Kingdom for Rhodesian Africans.
