

ICS 70 SANDBACH TINNE & CO.

James McInroy came to Demerara in 1782, and planted or acquired a sugar plantation soon after his arrival. By 1790 he was joined by Samuel Sandbach, Charles Stewart Parker and George Robertson and the company McInroy Sandbach & Co. was founded. At first the head office was in Glasgow under the name McInroy Parker & Co. and in 1804 a branch was formed in Liverpool which later became the company's headquarters. In 1813 Philip Tinne was taken into the partnership and the company became known as Sandbach Tinne & Co. in Liverpool and McInroy Sandbach & Co. in Demerara (in 1861 changed to Sandbach Parker & Co.) They were importers and exporters, Shipping and estate agents, mainly concerned with the trade in sugar, coffee, molasses and rum, but also in "prime Gold Coast Negroes" (J. Rodway: History of British Guyana, 1893, vol. 2, p.141). The families interMarried and the sons and sons in law entered the business.

The first accounts available at Companies House are for 1948. These show Parkers, a Sandbach and later a Tinne still involved in the Company. However they are part of a larger group Demerara Co. Ltd. In the early 1960s the Company experienced its first losses and several shake ups in the directorial board followed. In the accounts for 1967 the following declaration of principal activities was made:

"The company previously conducted the export business from Liverpool (excluding rum) both to Demerara Co. Holdings Group companies and to other customers, acting as Marketing agents for Demerara Company Ltd's sugar, provided the administrative services at the parent group's head office and acted as holding and financing company for various members of the DCH Group. During the year export sales to other customers were transferred to a subsidiary company W.F. Gouda & Co. Ltd. (since renamed Sandbach Exports Services Ltd.) and from the beginning of the year Demerara Group Services Ltd., a newly formed subsidiary of DCH Ltd. took over the administrative function of the parent group.

The Company's subsidiaries are:

- K.R. Hunt & Co. Ltd – General merchants Barbados (75% owned)
- Sandbach Trinidad Ltd. – General merchants and automotive engineers, Trinidad.
- W.F. Gouda & Co. Ltd. – (since renamed Sandbach Export Services Ltd.) Export merchants UK.

Exports

During the year goods have been exported by the company from the UK to the value of £1,229,168 of which £579,961 was exported by the company acting as principal and £649,207 acting as agents."

Business continued to go badly and by 1969 the Company had been taken over by Jesel Securities. Sandbach Industries went into liquidation in 1969, and K. R. Hunt Ltd. and Sandbach Export Ltd. were sold off. On 22 May 1972 Peter Henry Gibbings and Timothy John M. Harrop, 2 shareholders and directors, made a declaration of solvency for a 'members' voluntary winding up. John Prentice was appointed liquidator at an Extraordinary general Meeting on 31 May 1972. At a general meeting of the Company on 14 Aug 1975 to show how the winding up had been conducted, there was no quorum present. Jessel Securities itself later went into liquidation.

It is not known where the Institute's holding of Sandbach Tinne & Co. correspondence comes from. It was purchased by a stamp dealer for the envelopes and then passed to us. Other archives of the Company have found their way to Guyana University Library, the national Maritime Museum Greenwich, and the Lancashire Record Office. Details of their holdings, correspondence about the purchase, and some general material on the Company are kept in the 'K index' file. Xeroxes of family tree and lists of ships held by Liverpool record Office are kept with the ICS letters for the convenience of users.
